

## Application for hardship compensation for the social contribution of the student body/semester ticket NRW

**Important:** This application is an application for **financial hardship compensation**. The question, if the ticket can still be used does not play any role in this context. Whoever will get the contribution of the student body (including semester ticket) waived can, of course, still use the ticket.

Students who cannot use the ticket because of a stay abroad, an internship, who are on leave or have a right for transportation under the severely disabled rule can get a refund for the semester ticket at the general students' committee's office (AStA).

All other students of TU Dortmund can submit this application for hardship compensation. - **All statements of your bank accounts for the last 3 Months (from all your bank accounts, credit cards...)**
- Prove of income/alimony payments (e.g. saving accounts, bank account statements...)
- Prove of your wealth (e.g. saving accounts, building saving contracts...)
- Rental contract, electricity, and gas contract
- Possibly: ID and registration certificate
- Possibly: Prove of health insurance amount
- Possibly: Birth Certificate of own dependent children
- Possibly: (German) Federal Law on Support in Education notification
- Student ID or certificate of enrollment
- For freshmen/first enrollers preliminary certificate of enrollment
